CITY COUNCIL CHAMBERS 400 EAST MILITARY, FREMONT NEBRASKA
June 26, 2018
7:00 p.m.

After Study Session and Pledge of Allegiance, the Mayor called the meeting of the City Council to order and stated that a copy of the open meeting law is posted continually for public inspection located near the entrance door by the agendas. Roll call showed Council Members Anderson, Kuhns, McClain, Landholm, Jacobus, Bechtel, Legband and Schaller present. 8 Council Members present.

Ordinance to rezone from R Rural to GI General Industrial by Dana Leland, owner of property located at 4173 North Yager Road (first reading). Mayor Getzschman opened the public hearing. Mayor Getzschman closed the public hearing after receiving comments from the public. Council Member Landholm moved, seconded by Council Member Kuhns to hold first reading of the Ordinance. Ayes: Anderson, Kuhns, McClain, Landholm, Jacobus, Bechtel, Legband and Schaller. Motion carried. City Clerk provided first reading of the Ordinance.

Resolution for request of Calvin Hinz on behalf of Eden and Cyndi Whitten for conditional use permit for UR zone for assisted living at 915 North H Street. Mayor Getzschman opened the public hearing. Council Member Schaller moved, seconded by Council Member Jacobus to receive into the record a document titled Shiloh Place. Ayes: Anderson, Kuhns, McClain, Landholm, Jacobus, Bechtel, Legband and Schaller. Motion carried. Mayor Getzschman closed the public hearing after receiving comments from the public. Clarify fencing materials and requirements in §11-614.02 (Residential Districts), and §11-615.02 (Non-Residential Districts). Mayor Getzschman opened the public hearing. Mayor Getzschman closed the public hearing after receiving comments from the public. Lot area and open space standards in Article 6, Section 11-602, Table 11-602.01. Mayor Getzschman closed the public hearing after receiving comments from the public. To consider allowing bars/taverns, alcohol sales

and restaurants in the GI and LI districts by conditional use permit in Table 11-502.03 and 11-504.03. Mayor Getzschman opened the public hearing. Mayor Getzschman closed the public hearing after receiving comments from the public. Minimum Street Frontage requirements and Minimum Lot Sizes in the City of Fremont Zoning Ordinance, Article 6, Section 11-603, Table 110603.01.01. Mayor Getzschman opened the public hearing. Mayor Getzschman closed the public hearing after receiving comments from the public. Council Member Schaller moved, seconded by Council Member Landholm to hold first reading of the Ordinance. Mayor Getzschman stated that Zach Carlson Extraterritorial Jurisdiction appointment would be removed from the list of appointments because State Statute allows only one member of the Planning Commission to serve on the Board of Adjustment. 


