
ROLL CALL Roll call showed Council Members Ellis, Ganem, Yerger, Sookram, Legband, and Jensen present. 6 members present.


Ordinance. Ayes: Ganem, Jensen, Sookram, Legband, Spellerberg Nays: Ellis, Yerger.
