March 24, 2020



SPECIAL MEETING:

1. Meeting called to order. After the Pledge of Allegiance, Mayor Getzschman called the Special Meeting of the City Council to order and stated that a copy of the open meeting law is posted continually for public inspection located near the entrance door by the agendas.
2. Roll call. Roll call showed Council Members McClain, Ellis, Bechtel, Yerger, Jensen, Jacobus, and Legband present. 7 Council Members present. Kuhns absent. Council Member Kuhns joined the meeting by 7:20 PM.
3. Test Zoom Telecommunication software. No action was taken.
5. Consider temporary suspension of the Public Comment period during the COVID-19 pandemic. Council Member Jensen moved, seconded by Council Member Legband to approve temporary suspension of the Public Comment period during the COVID-19 pandemic. Council Member Legband moved, seconded by Council Member Jacobus to approve COVID-19 compensation plan for hourly employees as amended.
